This is the basic charge to each family for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing of death certificate and permit (county fee's not included), consultation with the clergy, cemetery, crematory or common carrier, planning the funeral or memorial service and placement of obituary notices. There will be an additional charge for the direction and supervision of each service requested or required. This fee is for our basic services and overhead and will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving of remains.)

EMBALMING.....\$ 590.

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by the state of California must complete this procedure.

DIRECT CREMATION... (urns, alternative containers, cash advances and sales tax are not included) \$ 2,250.

Our charge for a direct cremation (without ceremony) includes: the basic services of funeral director and staff for obtaining, completing, and filing legal documents, proportionate share of overhead costs, 24 hour local transfer of decedent to funeral home from healthcare facility or residence, refrigeration (72 hours) and the cremation at our crematory. This discounted package will provide cremated remains available for return in approximately seven (7) days from date of arrangement. Priority handling of the cremation is available for an additional fee.

If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be made of material like fiberboard and composition materials. The alternative containers we provide are constructed of wood and/or cardboard material.
